REPRODUCTIVE JUSTICE FOR ALL

The struggle for reproductive justice needs your help. Through the *Reproductive Justice Funding Initiative: Donor Challenge*, the Fund for Southern Communities (the Fund / FSC) is moving financial support in the form of grants to reproductive justice organizations in the south. **Every dollar we raise for the challenge will be matched 100%, up to \$100,000!**

Recently, FSC was selected to be one of only 13 foundations in the nation to receive a matching grant from the Catalyst Fund of the Tides Foundation, a national program to build a stronger and more unified movement for reproductive justice. Reproductive Justice organizations, which operate using a winning strategy framed by cooperation, justice and inclusivity, are drastically under funded. These groups make essential contributions to the success of the whole reproductive rights and health movement.

Reproductive Justice is a framework that links reproductive rights to broader structures of inequality. It enhances traditional efforts to include other policies and conditions that affect reproductive health, such as family violence, toxic environments, human trafficking and other issues of fair treatment, access and equity. Within the reproductive justice framework there is a space to address the reproductive health needs of *all* women, not just a select few. The Fund for Southern Communities embraces reproductive justice for its contribution to the larger need for structural transformation, self-determination, immediate action and freedom of all marginalized communities.

Grantee partners of the Fund's reproductive justice grantmaking will be organizations led by women that are addressing the immediate reproductive health disparities by creating solutions and policies that best address the needs of their communities, which in the south are the highest in the nation. The power of reproductive justice organizations in the south is exemplified through the multiple invitations from the White House to Atlanta's [SisterSong: Women of Color Reproductive Health Collective](#) to discuss the Obama Administration's reproductive policy measures.

Even President Obama is clued in to the need to fight the battles of reproductive inequity using a more inclusive and justice-based framework, as indicated the following quote: "A woman's ability to decide how many children to have and when, without interference from the government, is one of the most fundamental rights we possess. **It is not just an issue of choice, but equality and opportunity for all women.**"
